Our Terms of Business include the following:

We will provide an estimate of all charges likely to be incurred on the basis of the information and details we know at the date of estimate. While we make every effort to ensure the accuracy of the estimate, the charges are liable to alteration particularly where third parties change their rates or charges.

We may not know the amount of third party charges in advance of the funeral, however we will give you a best estimate of such charges on the written estimate. The actual amount of the charge will be detailed and shown in the final account.

Our funeral account is due for payment within 30 days from the date of account, unless otherwise agreed by us in writing.

If you fail to pay us in full on the due date, we may charge you interest at the rate of 4% above the bank's base rate. The interest will accrue daily from the due date until the date of payment. You must pay us interest together with any overdue amount. In exceptional circumstances we may employ the services of a debt recovery agency to secure payment on our behalf. You must pay us all reasonable costs, fees, disbursements, and charges (including legal fees) incurred by us in the recovery of any debt.

We may ask you to pay a deposit prior to the funeral taking place.
